Can you imagine not being able to manage many areas of your life due to various involuntary reasons, and at the same time have NO family or friends able to assist you when you have to make important life decisions?

This frightening scenario happens much more often than most people realize. “You Are Never Alone,” the mantra of Volunteer Guardianship One-on-One, Inc. serves as a reminder to those who dedicate their time and resources to help fellow members of the community. The organization coordinates volunteers to provide compassionate and complete guardianship services to adults who have no willing family members or friends, and have been determined by the judicial system to be “incapacitated” and need of such services.

The organization developed in the 1990s when the New Jersey Office of the Public Guardian was under budget constrictions and a moratorium was placed on new cases. Hunterdon County Surrogate Susan Hoffman and local attorney Anthony Serra came up with the idea of using volunteers as a way to address the problem of persons who had no one to care for them and were essentially abandoned by the State.

A guardian is a person appointed by the court to make life decisions for another person whom a judge determines to be incapacitated. A guardian may be anyone. Important issues on where to live and how to manage their finances become the responsibility of the guardian.

Our volunteers are “never alone.” They must first become trained in the policies and procedures included in our Volunteer Handbook before they are assigned a ward. We offer ongoing workshops throughout the year and have a board of highly qualified people to answer any concerns or questions. The continuing growth of incapacitated persons has caused Volunteer Guardianship One on One to be more important now than ever. As you read through the following material, we hope you will realize the importance of this organization in our community. It is also our wish that you can help either by volunteering or through an enabling monetary donation. Thank you for your interest and remember that no matter what, you are never alone.

Frequently Asked Questions, Page 1 of 2

WHAT IS A GUARDIAN?

A Guardian is an individual who has been appointed by the court to make decisions for another person.

A person may require a Guardian for many reasons, including illness or injury. If a judge determines that the person is “incapacitated,” a Guardian is appointed.

A Guardian may be a family member, a neighbor, a friend, or a professional guardian. In some cases, a Volunteer Guardian or the State Public Guardian may be assigned.

WHAT ARE THE RESPONSIBILITIES OF A VOLUNTEER GUARDIAN?

A Volunteer Guardian makes all life decisions for his/her “ward.” Important issues such as where to live and how to manage their finances become the responsibility of the Guardian.

“OUR VOLUNTEERS ARE NEVER ALONE”

Volunteer Guardians make these decisions with the assistance of volunteer professionals individuals and social service agencies.

WHAT IS THE BACKGROUND OF A TYPICAL VOLUNTEER GUARDIAN?

There is no typical Volunteer Guardian. Education, age, economic status, race and religious preference are all varied and welcomed. The only real requirement is that all volunteers share a strong desire to do something meaningful for another person.

WHAT TRAINING WILL BE PROVIDED?

Volunteer Guardians are “never alone.” Before being assigned a ward, a volunteer becomes thoroughly familiar with the policies and procedures included in the “Volunteer Handbook.”

Opportunities for continued professional development abound, through educational programs sponsored by Volunteer Guardianship One-on-One, and The Guardianship Association of New Jersey, Inc. (GANJI). Volunteers have the opportunity of earning the Registered Guardian (RG) credential.

WHAT HAPPENS IF I MUST BE AWAY FROM HOME?

No problem at all. Most wards are happily settled in their homes or in a care facility. Daily contact is not required. To be certain that decisions can be made even when the Guardian is unavailable, a “Power of Attorney” is arranged to allow availability of a substitute Guardian.

WHO DO I ASK FOR HELP?

Remember, our Guardians are never left alone!

The members of our Board of Trustees are persons actively engaged in legal, medical, religious, nursing and social services in Hunterdon County, New Jersey. All are personally committed to the Guardian’s success. Each is available whenever needed to answer a question, to provide guidance, or to help a Guardian make an important life decision.

Just some of the people we can and have helped...

- Carl has had a severe stroke and cannot communicate and sits alone in a nursing home. He has no one to look out for his best interests.
- Mary was never married, has no siblings or living relatives. She is 90 and all her friends are gone. She was found in her home, alone with her advanced dementia. Adult Protective Services stepped in. Who will look after her best interests?
- Stan was at mental institution but now that he is on medication he is able to be moved to a supervised group home, but he has no one to ok his release.

Legally Incapacitated definition: determined by a Judge to be temporarily or permanently impaired by mental and/or physical deficiency, disability, illness, or by the use of drugs to the extent he or she lacks sufficient understanding to make rational decisions or engage in responsible actions.

Legal Guardian definition: Guardianship is generally defined as a legal arrangement under which a person (a guardian or fiduciary) is given the legal right and duty to care for another and his or her property (commonly referred to as the ward). A guardianship is established due to the ward's inability to legally act on his or her behalf because of mental or physical incapacity.

As our aging population grows we see more and more Alzheimer's, Dementia and Strokes. Many of these people are alone and have no one willing or able to step up and be their guardian. That is why they need you!
